Among other products, importing the following items is prohibited: pork meat, fat, hair, blood, guts, members, and anything extracted from it; frog meat; liquors and intoxicants of all kinds; and equipment for gambling. 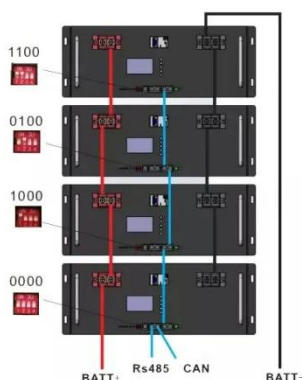
