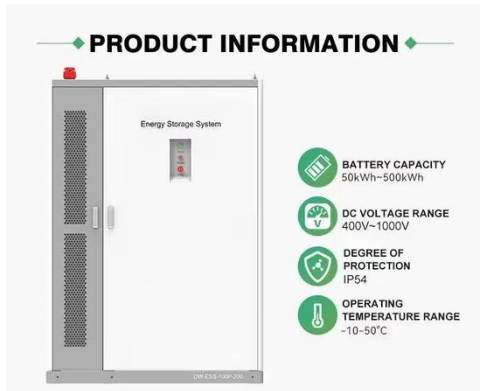

Research published in the journal *Frontiers — Sustainable Energy Policy* finds that 82% of people who live within an hour's walk (about 3 miles) of large scale solar installations find they make good neighbors. If solar energy systems installed on your property are adversely impacting your neighbors, several steps can be taken to address the issue efficiently and amicably.

Assess Legal. Missions from other sources of generating electricity.
