

Electricity regulations northern cyprus



Overview

Northern Cyprus does not have a unified, codified Energy Law like many countries, but energy governance operates under several laws and regulations, mainly focusing on electricity, renewable energy, and fuel supply: Electricity Law (No. 37/2013). The Electricity Authority of Cyprus was established under the Electricity Development Law Cap. 171 of 1952, in order to exercise and perform functions relating to the generation and supply of electric energy in Cyprus, operating within its own legal framework. Under this law EAC has the authority to. 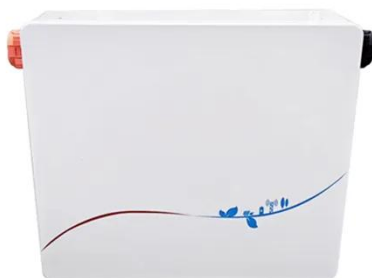
