

Investment in corporate solar power generation projects



Overview

Total corporate funding, including venture capital (VC) funding, public market, and debt financing into the solar sector, decreased 16% year-over-year (YoY) in 2025, with \$22.2 billion raised in 175 deals, compared to \$26. According to a June 2025 report from Lazard, renewables like solar energy are the cheapest source of power on the market. This cost-effectiveness may present enticing investment opportunities for some but, like any venture, investing in solar power requires a solid grasp of the industry. Private equity (PE) has emerged as a cornerstone of clean energy finance, deploying \$1. This trend is reshaping the energy market, propelled by a combination of supportive policies and increasing demand for sustainable energy. If you're building a solar, wind, or battery storage company, you need investors who actually understand renewable energy—not just VCs who checked "climate tech" off a list because it's trendy.

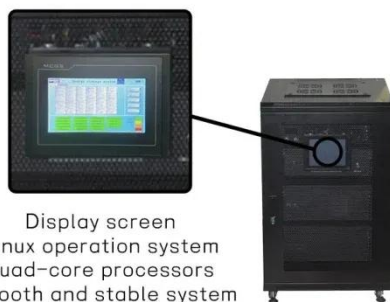
