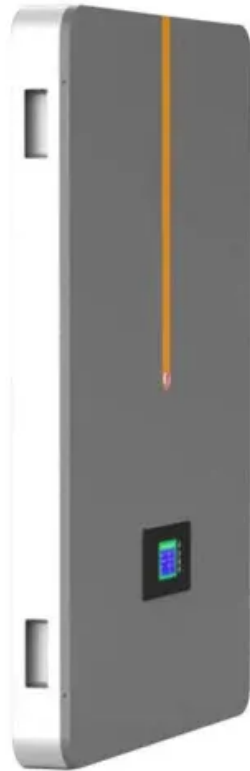


Life ban electricity storage



Overview

People living in some neighborhoods are now worried about what could happen with hundreds of lithium-ion batteries that are being stored in metal containers near their homes and businesses. They're called Battery Energy Storage Systems or BESS plants. has grown dramatically in the U. in recent years, they are facing resistance in some communities where residents have voiced concerns over the risk of energy storage system fires and the amount of space required to install storage. Senate Bill S5506 proposes to transfer the approval and siting of to the hands of an unelected state agency, the Office of Renewable Energy Siting, overriding local moratoriums and zoning laws enacted for public safety.

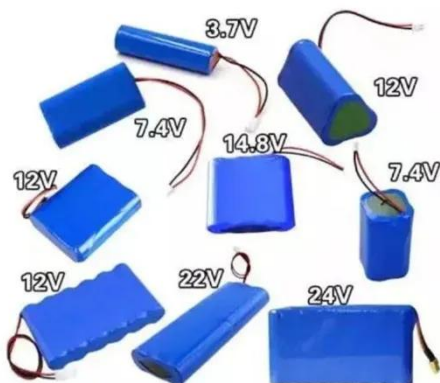
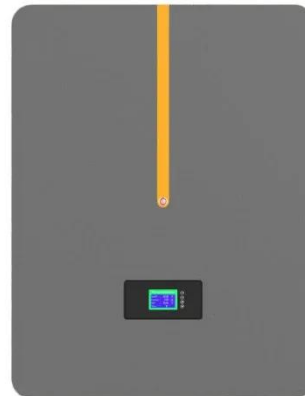
