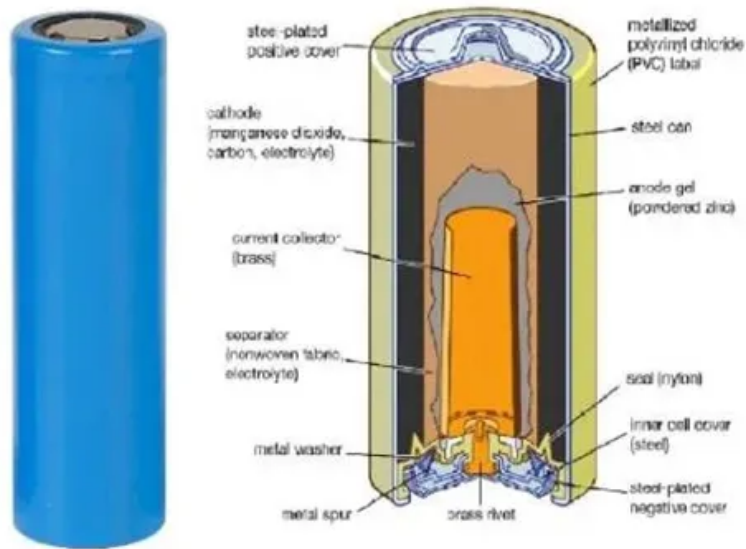


Solar panel manufacturers contract

A solar contract is a signed agreement between a person and a solar power installation company that clearly outlines every part of the solar panel installation process, including the steps before, during, and after the actual installation, and who is responsible for each. A Solar Power Purchase Agreement (SPPA) is a financial arrangement in which a third-party developer owns, operates, and maintains the photovoltaic (PV) system, and a host customer agrees to site the system on its property and purchases the system's electric output from the solar services provider.
