" If signed into law as currently written, homeowners will need to install solar and/or battery storage by Decemto qualify for this tax credit before it is gone. This solar energy tax credit was recently increased with a new plan to be phased out over the next 10 years.

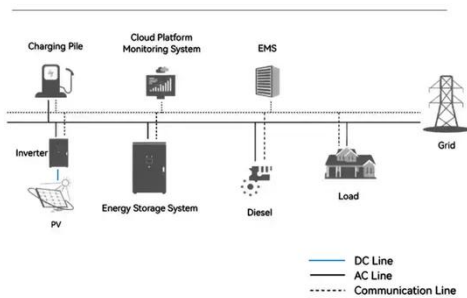
