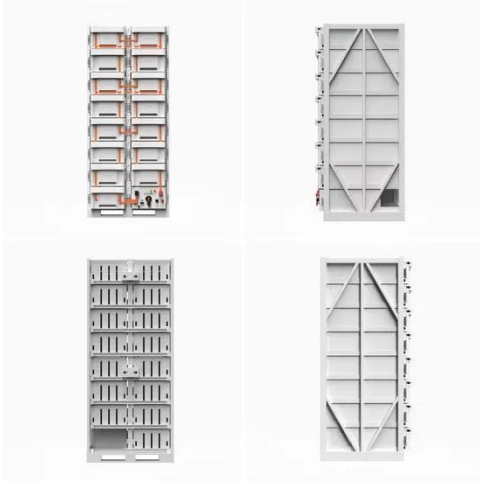
## Overview

Solar panel tax exemption renewable energy programs offer substantial savings through federal 30% tax credits, state property tax exemptions, sales tax exemptions, and commercial accelerated depreciation benefits. Solar tax exemptions include both property and sales tax exemptions provided by state and local governments to individuals and companies that install solar energy property. Strategic timing and proper documentation maximize these incentives, potentially. The ITC allows owners of solar energy systems to deduct 30 percent of the cost of installing the system from their federal taxes.
