

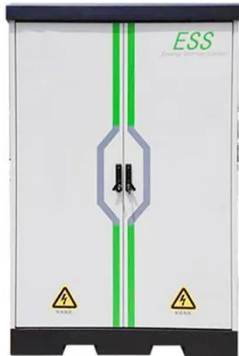
Which countries are anti-dumping for photovoltaic panels



Overview

On April 11, the U. Department of Commerce announced its final affirmative determinations in the antidumping duty (AD) and countervailing duty (CVD) investigations of crystalline silicon photovoltaic cells (solar panel cells) from Cambodia, Malaysia, Thailand, and Vietnam. Cells and modules from Vietnam, Malaysia, Thailand and Cambodia are affected. With the ITC just issuing its affirmative preliminary determination, we thought now was an appropriate time to answer these questions.

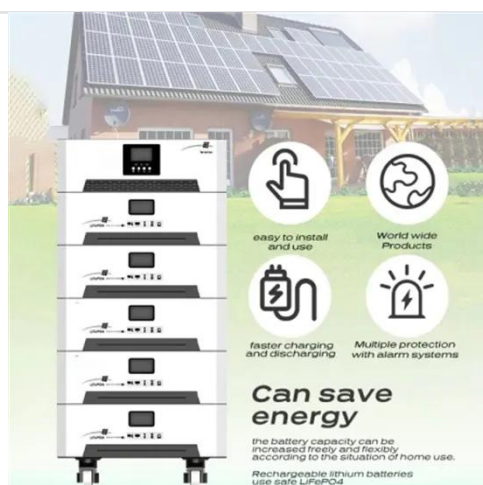

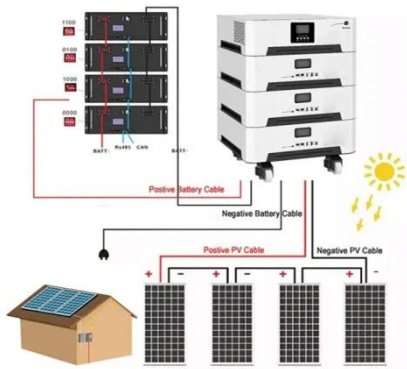
